

# Website Accessibility Statement for Private Entities under Article 3, Paragraph 1 of Law No. 4 of January 9, 2004

## Statement

Elsa SRL is committed to making its website accessible, in accordance with Law No. 4 of January 9, 2004. This accessibility statement applies to: <https://elsasrl.com> and the subdomain <https://pages.elsasrl.com>.

## Compliance Status

### Partially compliant

The Web Content Accessibility Guidelines (WCAG) define requirements for designers and developers to improve accessibility for people with disabilities. They define three levels of compliance: Level A, Level AA, and Level AAA. Elsa is partially compliant with WCAG 2.1 Level AA. "Partially compliant" means that some parts of the content do not fully conform to the accessibility standard.

## Limitations and Alternatives

Some website content is not accessible for the following reasons of non-compliance with Law No. 4 of January 9, 2004:

- Some non-text content presented to users does not have a text alternative that serves the same purpose;
- In some cases, information, structure, or relationships conveyed through presentation cannot be programmatically determined (or are not available via text);
- In some cases, where the sequence in which content is presented affects its meaning, it is only visual and not structural;
- In some cases, color alone is used to convey information or distinguish an element or function;
- The visual representation of text and images containing text does not always meet the required minimum contrast ratio, except in cases allowed by law (e.g., logos);

- Some text, except for captions and images containing text, cannot be resized up to 200% without assistive technologies and without loss of content or functionality;
- In some cases, images of text are used instead of plain text and are neither customizable nor essential for the conveyed information;
- Content that does not require two-dimensional presentation (such as data tables or maps) does not reflow when the display size is changed by the user agent;
- For some essential components, even in different states, the color contrast with adjacent elements does not exceed a 3:1 ratio;
- When adjusting text spacing (line height, spacing between paragraphs, letters, or words), some information or content may be lost;
- In some cases, when mouse hover or keyboard focus reveals or hides content, there is no mechanism to dismiss the additional content without moving the pointer or focus, the pointer cannot move to additional content without it disappearing, or the content does not remain visible until hover/focus is removed, dismissed by the user, or the content becomes irrelevant (except for certain allowed exceptions);
- Some functionalities are not operable via keyboard (or a similar input interface);
- There is no mechanism to skip blocks of content that repeat on multiple web pages;
- Some web pages lack titles that describe the topic or purpose;
- In some sequentially navigable web pages where sequence affects meaning and functionality, some focusable items are not navigated in an order that preserves meaning and operability;
- The purpose of some links cannot be determined from the link text alone or from the link text together with surrounding content;
- Headings and/or labels do not sufficiently describe content or functionality;
- The focus indicator is not visible on some interactive elements;
- The language of some pages is not defined;
- In some cases, phrases or passages in a different language are not identified in the code;
- In some cases, when input errors are automatically detected, the erroneous item is not identified and/or the error is not described in text;
- In some cases, labels or instructions are not provided when user input is required;
- In some cases, user interface components (including form elements, links, and script-generated components...) do not have correct or set name, role, states, properties, and values, or the user and assistive technologies are not notified when these change;
- In some cases, status messages are not presented in a way that assistive technologies can interpret them without moving focus.
